Overview

Is China dumping solar panels?

Following an application made by domestic manufacturers, the Directorate General of Trade Remedies (DGTR) under the commerce ministry has initiated an anti-dumping probe into the solar cells, whether or not assembled into modules or panels, coming from China, Thailand and Vietnam .

Are imported solar cells harming the US solar market?

The preliminary determinations are the second set to be announced in a trade case brought by The American Alliance for Solar Manufacturing Trade Committee earlier this year, over concerns that imported solar cells from Cambodia, Malaysia, Thailand and Vietnam are harming the US domestic solar market.

Will a USITC ruling affect PV imports from Southeast Asian countries?

The U.S. International Trade Commission (USITC) is scheduled to determine in June 2025 whether PV product imports from these four Southeast Asian countries have damaged the US domestic industry. If the USITC issues an affirmative ruling, the final AD/CVD rates will be imposed as scheduled.

How much is the DoC imposing on solar cells & modules?

At the start of October, the DoC announced a preliminary decision on countervailing duties (CVD) for solar cells and modules imported from the four countries, with rates ranging from 0.14% to 292.61%, depending on company and country.

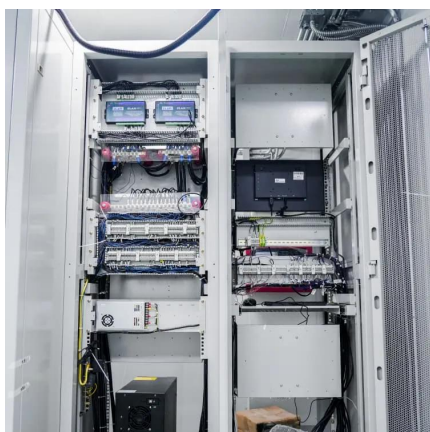

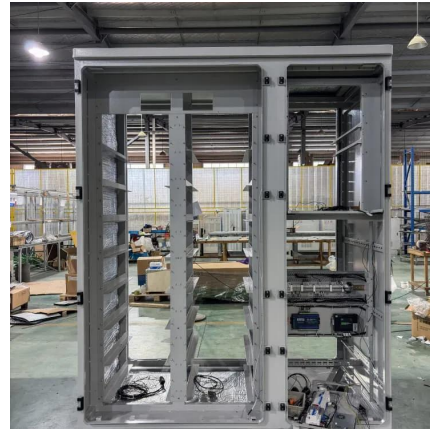
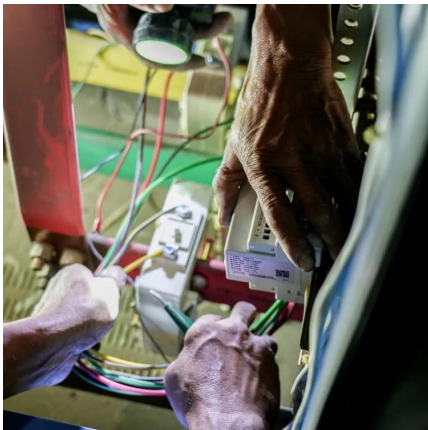
