What is the EU Battery regulation 2023/1542?

More specifically, in the battery space, the EU Battery Regulation (EU) 2023/1542, will introduce stringent requirements for the removability and replaceability of batteries in some battery powered products in 2027. Effective from February 18, 2027, these requirements aim to enhance product longevity and facilitate battery recycling.

How long will a battery due diligence deadline be delayed?

On 21 May 2025, the European Commission proposed a two-year delay to the battery due diligence obligations under Regulation (EU) 2023/1542—shifting the deadline from August 2025 to 18 August 2027. While this extension provides more time to prepare, it also raises critical questions for battery stakeholders:.

What are the new EU Battery regulations?

Effective from February 18, 2027, these requirements aim to enhance product longevity and facilitate battery recycling. Which products are affected?

The EU battery regulation defines different battery categories based on their application, and the requirements on removability and replaceability will only apply to two of these categories:.
