Can you carry a lithium battery with a power tool?

Lithium batteries installed in power tools can be packed in checked luggage, though spare lithium batteries must be carried on. Before traveling with your power tools, it's best to check with your airline and/or the TSA for up-to-date information on transporting them by plane.

Can you take battery-powered tools on a plane?

Now comes the answer. Yes, you can take battery-powered tools on a plane, but there are specific regulations regarding the batteries that power these tools. Most battery-powered tools use lithium-ion batteries, and the Federal Aviation Administration (FAA) has strict rules on how these batteries can be transported to ensure safety.

Do power tools need to be packed in checked bags?

Checked Bags: Yes (Special Instructions) Power tools must be packed in checked bags, including drills and drill bits. Power tools with installed batteries must be packed in checked bags. Batteries installed in devices must be protected from accidental activation.

Are power tools allowed in checked luggage?

Gas and battery-powered tools are permitted in checked bags, but it's important to check gas-powered tools for residue, as this may be considered hazardous. Lithium batteries installed in power tools can be packed in checked luggage, though spare lithium batteries must be carried on.


