What are the new solar power procurement revisions for 2025?

Notified on February 12, 2025, these revisions aim to streamline solar power procurement, bolster accountability, and ensure a transparent and efficient bidding ecosystem.

How to promote competitive procurement of electricity from solar PV power plants?

Promoting competitive procurement of electricity from solar PV power plants, by Distribution Licensees. Facilitating solar PV capacity addition and fulfilment of Renewable Purchase Obligation (RPO) and Energy Storage Obligation (ESO) requirement of DISCOMs.

What are the technical parameters for solar PV/energy storage systems?

The detailed technical parameters for Solar PV/ Energy Storage Systems shall be as specified by MNRE from time to time. Guideline Compliance Strict adherence to these guidelines is mandatory. Any deviations must be approved by the Appropriate Commission before the initiation of the bidding process.

Can a generator supply power outside the scope of a PPA?

If a project consists of multiple components (wind, solar, or other renewable energy power generating systems), and one or more components are ready to inject power into the grid while the remaining components are unable to commence power supply, the generator has the option to supply power from the ready components outside the scope of the PPA.

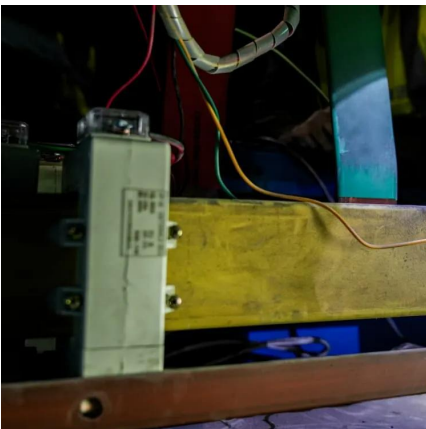
